**OVERVIEW:**

- The *Municipal Act, 2001* requires that an annual Statement of Remuneration and Expenses paid to each Member of Council and each person, other than a Member of Council, including a local board in respect of his or her services as a member of the body, be presented to Council on or before March 31, in respect of the previous year.

**Background:**

Section 284(1) of the *Municipal Act, 2001* requires that "the Treasurer of a municipality shall in each year on or before March 31 provide to the council of the municipality an itemized statement of remuneration and expenses paid in the previous year to,

- a) each member of council in respect of his or her services as a member of the council or any body, including a local board, to which the member has been appointed by council or on which the member holds office by virtue of being a member of council;
- b) each member of council in respect of his or her services as an officer or employee of the municipality or other body described in clause (a); and


- c) each person, other than a member of council, appointed by the municipality to serve as a member of any body, including a local board, in respect of his or her services as a member of the body.”
